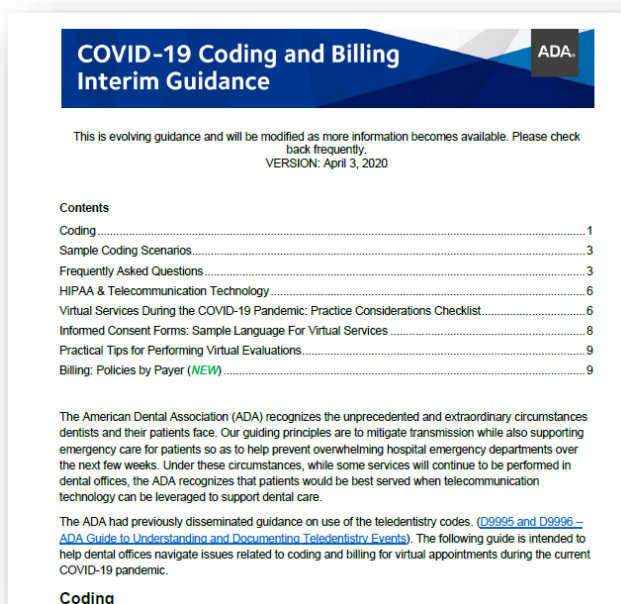
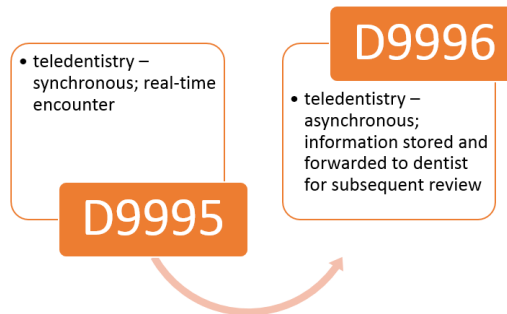

Dentists Defined as Physician/Practitioner

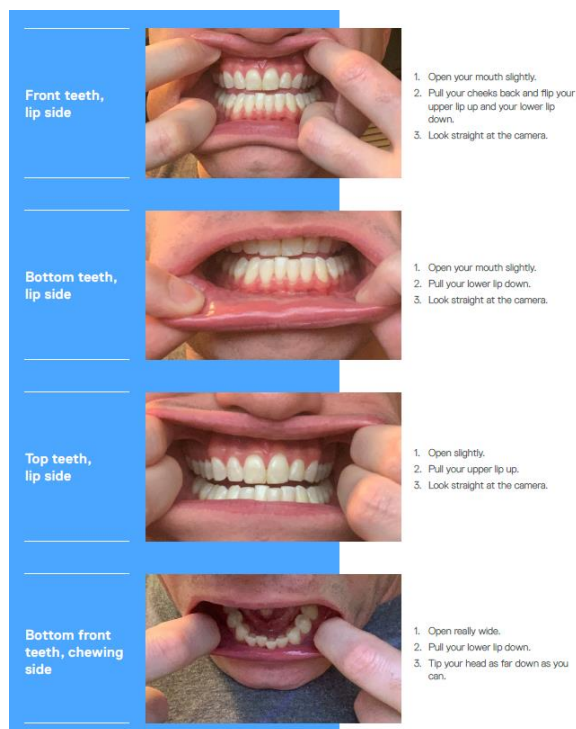
The Centers for Medicare and Medicaid Services (www.CMS.gov) covers more than 100 million people. Some of them are your dental patients. CMS redefined the term Physician/Practitioner as the quote below indicates:

‘3044.4 - Definition of Physician/Practitioner. For purposes of this provision, the term "physician" is limited to doctors of medicine; doctors of osteopathy; **doctors of dental surgery or of dental medicine**; doctors of podiatric medicine; and doctors of optometry who are legally authorized to practice dentistry, podiatry, optometry, medicine, or surgery by the State in which such function or action is performed; no other physicians may opt-out. Also, for a purpose of this provision, the term "practitioner" means any of the following to the extent that they are legally authorized to practice by the State and otherwise meet Medicare requirements: physician assistant, nurse practitioner, clinical nurse specialist, certified registered nurse.’ –CMS 2013

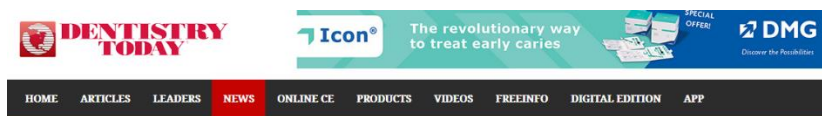
